## Market Summary

The stock market on Monday remained negative throughout the day and concluded the session in the red zone amid profit taking by investors. The Benchmark KSE-100 index made an intra-day high and low at 185,650.59 (1,521.01 points) and 180,992.79 (-3,136.79 points) respectively while closed at 182,340.38 by losing 1,789.20 points. PKR in today's interbank appreciated by Rs 0.0097 against USD and closed at Rs 279.7022. The value of shares traded during the day was Rs 58.801 billion. Market capitalization stood at around Rs20.699 trillion. Overall, trading volumes for the day increased to 1266.27 million shares compared with Friday's tally of 1193.66 million. KEL was the volume leader with 302.4 million shares, gaining Rs0.48 to close at Rs9.42. It was followed by BOP with 53 million shares, losing Rs0.39 to close at Rs39.7 and AGHA with 47 million shares, gaining Rs0.34 to close at Rs8.98.




