Market Summary

The stock market on Thursday remained negative throughout the day and concluded the session in the red zone amid profit taking by the investors. The Benchmark KSE-100 index made an intra-day high and low at 182,757.08 (-292.72 points) and 178,725.24 (-4,324.56 points) respectively while closed at 180,512.64 by losing 2,537.16 points. PKR in today's interbank appreciated by Rs 0.0097 against USD and closed at Rs 279.6518. The value of shares traded during the day was Rs 41.680 billion. Market capitalization stood at around Rs20.428 trillion. Overall, trading volumes for the day decreased to 731.27 million shares compared with Wednesday's tally of 1057.65 million. KEL was the volume leader with 176.9 million shares, losing Rs0.38 to close at Rs8.22. It was followed by CENERGY with 52.2 million shares, losing Rs0.31 to close at Rs7.85 and AMTEXNC with 39.7 million shares, losing Rs0.64 to close at Rs4.67.

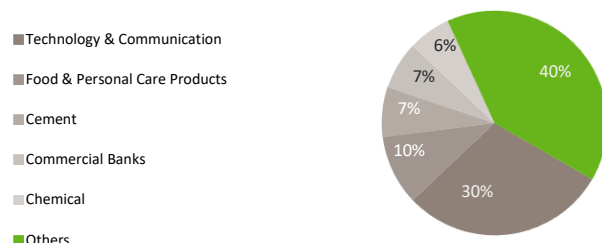

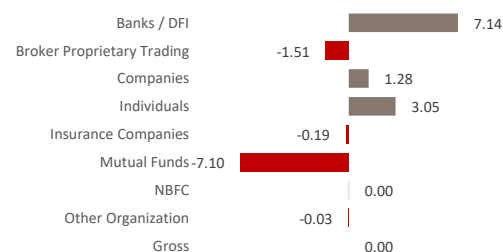

Overall Sector Turnover (%)

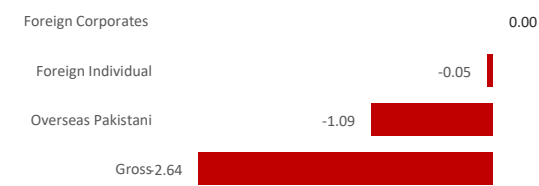

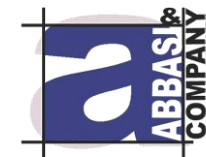

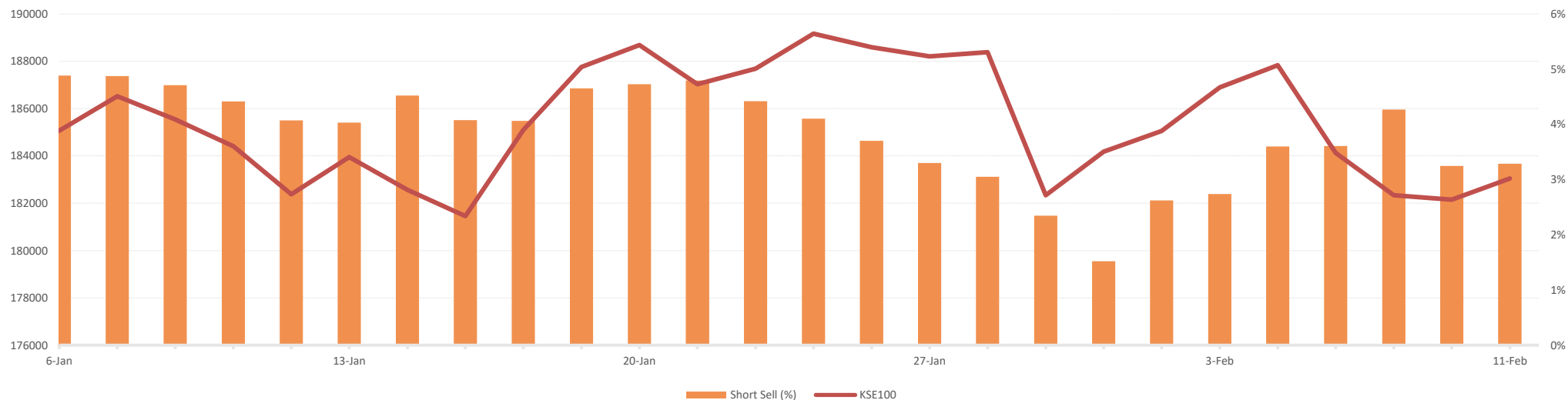
